

Additional clause to payment conditions valid for all enrolments received by December 18th, 2020.

With reference to the enrollments of February 2021 Intake, in consideration of the Covid-19 current situation, this clause is an integration to the general contract conditions and replaces art. 3 of the same only in the following instances::

1. declaration of a full lock-down due to Covid-19 ordered by health or government authorities of the student's city of residence and age group to which they belong which lasts until the start date of the course;
2. declaration of a full lock-down due to Covid-19 ordered by health or government authorities of the city in which the course is due to take place, which lasts until the start date of the course and/or arrangements by the Italian health or government authorities that make it impossible, up to 30 days from the course start, for NABA to conduct the courses "de visu";
3. total impossibility to reach the destination of the course of study due to proven limitations to travel (i.e. blocking of air traffic) imposed for the age group of which the student belongs due to Covid-19, by the government or health authorities of the student's city of origin or city where the course is due to take place which last until the start date of the course, and only where NABA fails to indicate different itineraries that allow the student to arrive at the course location;

If any of the above cases from 1 to 3 occurs, NABA will guarantee to the student the possibility to start the course through the e-learning mode with study path continuity and to reach the course location once possible, according to the health and government authorities regulations, provided that:

- a) the student provides official documentation with legal value issued by government, health or transport authorities, certifying the occurrence of one of the conditions indicated in this paragraph in points 1 and 3;
- b) the aforementioned documentation passes the school's board validity assessment;
- c) sends their refund request via PEC or registered letter no later than 30 days before the scheduled start date for the course in which they are enrolled. Requests presented outside the aforementioned terms with adequate motivation will be assessed on a case-by-case basis.

As last resort and only after having evaluated the above option (e-learning), it will be possible to ask for the course postponement to the following intake: October 2021, provided that:

- a) the student, before presenting the request, has fulfilled the payment of the tuition fee in full;
